New Central Heating Scheme – Funding Available

Does your home have storage heaters, room heaters or a solid fuel fire? If it does then you might be eligible for funding to upgrade your heating facilities through our new Warm Homes scheme.

As a council, we have funding in place to help residents that meet certain criteria save energy and money through the installation of a new central heating system – this could be you!

We've checked your home's Energy Performance Certificate (which is publicly available) and it looks like you could benefit from a heating upgrade. If you meet the scheme's eligibility criteria then we could provide funding for the installation of:

- A new air source heat pump or oil boiler (with manufacturer's warranty)
- Up to seven radiators
- Thermostatic radiator valves (TRVs)
- A wireless digital programmer

In most cases the funding will cover 100% of the cost (Subject to survey).

By replacing your current system with an A-rated alternative, you can reduce your fuel bills and keep warm for years to come.
